- Anyone (regardless of age) is eligible (and encouraged to participate).
 - All contestants will compete against each other (regardless of age).
 - All minors (17 years of age and below) **MUST** have their parent or legal guardian complete the “Consent Form” section of the official Ox Roast Talent Show Application.
 - All contestants **MUST** turn in a completed application form and pay the application fee: (\$20 if you **PRE-REGISTER** by mail) or \$25 on the first day of the event. (contestants are urged to register early).
 - There is no limit to how many individuals can perform as a group (dance group, cheerleaders, etc).
 - Contestants may perform solo, duo or as a small group with instrumentation or with a track **AS LONG AS THEY CAN WALK ON STAGE AND PERFORM IMMEDIATELY** - no bands with drums, amplifiers, etc (this is **NOT** a battle of the bands style of competition).
- ~ ALL CONTESTANTS must be able to walk on stage and perform immediately.
- ~ There will be **NO** set-up time
- ~ There will be **NO SOUND CHECKS**
- ~ Standard music **BANDS** with drums, guitar amps, keyboards, etc are **NOT PERMITTED TO COMPETE** due to the time it takes for them to set-up, sound check, tear down and clear the stage ... we are sorry, this is not a “battle of the bands”.

Competitor must have a valid form of identification (photo ID) is required. This ID must show date of birth. If you are a minor and do not have a photo ID, a birth certificate must be shown at time of the first night of the competition or a copy of it sent with application if you choose to Pre-Register. If the contestant is 17 years of age or younger, a parent or legal guardian must complete the “minor permission” section of the application by the first night of the competition. **NO EXCEPTIONS.** Contestant is ineligible if he/she is a professional entertainer and/or has any type of formal talent representation and/or recording contract. All sections/requirements of The Official Rules and Regulations must also be met in order to be eligible.

Performance material: All contestants who will be singing to a music track **MUST PROVIDE A CD** in a case or sleeve for protection. The background audio CD provided for each night must **NOT CONTAIN ANY LEAD VOCALS** (background vocals are fine). Please make sure the CD is labeled properly with name of the contestant, original artist’s name and track title. It is highly-recommended the contestant brings a back-up CD.

Contestants must use CD, SMART PHONES, IPODS, iPADS ONLY - NO CASSETTES

Application & Fees:

In order to complete the application process, the following items must be properly completed and received before the performance.

- Application (All contestants must complete the application.)
- Minor Permission section of the application **MUST** be completed for anyone 17 years of age or younger by parent or legal guardian.
- Copy of photo ID (all participants must provide a copy of a photo ID that verifies age).
If photo ID does not have this information, a birth certificate will suffice.
- Application Fee: A (non-refundable) application fee of \$20 per contestant is required - If the application is received by August 28, 2017. Otherwise, there will be a \$25 fee for those who choose to wait and register on the first day just prior to the start of the competition. Please make sure checks are payable to: WJCA - please include in the memo: “Ox Roast Talent Show”.
